### **Outside In - Terms of your Membership**

Thank you for your interest in joining the QBE Insurance (Australia) Limited ABN 78 003 191 035 ('QBE') online research community ('Outside In'). If you choose to become a member of Outside In, you acknowledge and agree to be bound by the following Terms and Conditions of membership ('Terms').

#### **QBE and Service Provider**

QBE is an Australian insurance company regulated by the Australian Prudential Regulation Authority.

QBE uses a third party company (the 'Service Provider') to manage and maintain Outside In and to conduct market research surveys on QBE's behalf. The Service Provider will host and process your personal information on behalf of QBE. QBE has an appropriate agreement with the Service Provider to protect your information. The details about the Service Provider can be found by clicking on the 'Who manages Outside In?' tab.

Any reference to QBE includes the Service Provider (as appropriate).

# **Joining Outside In**

Membership is only open to Australian residents who are 18 years of age or over, who are invited to join by QBE. To join Outside In, you will be sent an email by QBE where you will be asked to complete a profiling questionnaire that will be managed and hosted by the Service Provider, and asked to provide certain personal information about yourself. This information helps QBE to identify different types of QBE customers and assist QBE with its future market research activities.

Once you submit your answers to the profiling questionnaire, and confirm your membership by clicking on the 'Confirmation' email link you will receive upon completion of the profiling questionnaire, you will become an active member of Outside In.

#### **Participation in Online Surveys**

As a member of Outside In, QBE or the Service Provider may contact you from time to time to take part in market research surveys about QBE's products, services, marketing and ideas.

The online surveys you will be invited to participate in will be conducted and hosted by the Service Provider.

Your contribution and feedback is very important because it will help QBE to improve the products and services it offers to its customers. Participation in QBE's market research surveys is at your discretion. Any comment or opinion made by you about QBE's products or services during your participation in Outside In, will be taken on board as feedback.

#### **Your Obligations**

If you wish to join Outside In, you agree to the following:

- · you will register for Outside In only once;
- all information that you provide as part of the profiling questionnaire you are required to complete as part of your registration or whenever you respond to any other surveys must be honest and your own responses to any questions you are asked;
- you are responsible for maintaining the confidentiality and security of your login and password, and for all acts or omissions that occur under your login and password;

QBE may end your membership to Outside In at any time and without notice to you for any reason.

# **Privacy Policy**

By completing the profiling questionnaire or any online survey, you consent to QBE (or the Service Provider on QBE's behalf) collecting and managing information about you in accordance with our Privacy Policy. Our Privacy Policy describes how we collect, disclose, store and use personal information as well as how to access it, correct it or make a complaint.

QBE will use the information collected as part of Outside In for QBE market research purposes only. QBE will NOT:

- Use your information, or allow your information to be used, for another company's market research; and
- Use the information you provide as part of your membership to Outside In to advertise or promote, goods or services to you.

Sometimes we might need to send your personal information overseas. The locations we send it to can vary but include the Philippines, India, Ireland, the UK, the US, China and countries within the European Union. The information collected as part of Outside In will be stored using cloud technology at the Service Provider's secure facilities located in Australia.

It's up to you to decide whether to give us your personal information, but without it you may not be able to participate in Outside In.

# Website tracking

QBE and the Service Provider may use 'cookies' to collect information when you visit the survey link or Outside In member portal. QBE may also utilise other technologies similar to cookies, including those which are embedded into or which accompany emails sent by QBE or the Service Provider. Please refer to the QBE Privacy Policy for details about managing cookies, the types of information we collect, what we use the information for and who we share it with.

#### **Prize Draws**

As a sign of appreciation for participating in Outside In, you may be entered into a prize draw for certain surveys you complete (not including the profiling questionnaire you complete to register). QBE or the Service Provider will notify you of the details for each prize draw (if applicable) by email with each survey. If you are a winner of any prize draw, you will be contacted by email by QBE or the Service Provider.

## **Emails**

You acknowledge and accept that QBE and the Service Provider may send you an email from time to time. QBE will preserve the content of any email that you send to, or receive from, QBE if it believes that it has a legal requirement to do so. Your email message content may be monitored by QBE employees for security issues including where e-mail abuse is suspected. QBE's response to you may also be monitored for quality assurance purposes.
