(*'Structural Damage' means damage to the primary structure that supports the floors and roofs which causes the structural integrity of the building to be compromised.*)

I/We declare that there is no known physical damage to land and/or property in the immediate vicinity of the property to be insured, (including Contents-only insurance), that has arisen from an earthquake that may result in damage to the property to be insured.

I/We declare that if, after completing this declaration, I/we become aware of any Earthquake Damage as described in any of the statements above, I/we shall notify QBE immediately.

Declaration

I declare that all answers and statements in this earthquake damage declaration are correct and complete in every respect, and agree that this declaration shall form the basis of, and be incorporated into, the contract of insurance which I have with QBE Insurance (Australia) Limited, New Zealand Branch.
