


You will be presented with a list of currently available products to you. Employers Liability and Statutory Liability risks will become available only once General Liability risk is loaded.

Policy header page

The Basic details section is also known as the header

Dependant on the product you choose, the first screen will be the 'Basic details/ Policy header' page. Any fields that are shaded are not editable. The 'Holding Underwriter' selection is compulsory.

Utilise the calendar function or free type in the given format to enter date fields. Click 'Next'



Note, backdating cover (i.e. inception date prior to the transaction date) and extending past a 12-month insurance period may result in a referral.

Click 'Next' to progress.

The occupation descriptions are driven by ANZSIC Codes. **The correct occupation is critical to rating and risk rules**, please ensure this always accurate.

The typeahead function searches as you enter text or the relevant ANZSIC code*



If you are a **property owner**, it is essential to reflect what the tenant does and add in the tenant information.

Refer to Tenant section for further instructions

*Note: QBE utilise a hybrid or the 1996-00 codes. This may differ from your policy administration/ closing system.

If you are unsure which Occupation to select, please contact the underwriter for guidance.

The Business Description is a free text field is **compulsory**. This should clarify the ANZSIC selected and will be reflected on the policy documentation.

The **Property owner ANZSIC codes** range between 571015 (Boarding House FRC construction) through to 571069 (Motel operation over two storey other construction, licensed) When adding or editing a property risk, where the ANZSIC Code is that of a property owner (refer range below), Broker Xchange will not let you proceed unless one tenant is added.

If a tenant is not added against this property risk, you will be presented with a validation message and will be unable to proceed to the summary screen.

Location details

Type the full street address to trigger the search. Select from the results presented.

You also have the option of searching on a map by dropping a pin at the desired location. To use the 'Find on Map' function click on the 'Find on Map' button which will open a pop up



To search for an address, click on the desired location on the map. The red pin will be placed on this location and a list of addresses will be shown to the left.

Click on the required address and click close. The field in Broker Xchange will be populated with the selected result. To remove the result, click 'Clear'



Alternatively, instead of placing the pin a search can be made by entering the address in the Search Box. Click on the required address and click 'Close' to populate the result in Broker Xchange.

All risks must have a location selected to progress.

Survey details

Input the 'Last surveyed' and 'Valuation Date'. Provide the documentation via the 'Add Document' function

'Survey Next' indicates when the next survey will take place. 'Survey work outstanding' is a tick-box that indicates the same.

Construction/Protection

These sections utilise drop down list and text fields to accurately detail the risk of the broker submission. Please complete all fields.

NBS - New Building Standards. Earthquake-prone buildings are given an earthquake rating, commonly referred to as a percentage of the new building standard (NBS). Buildings that achieve less than a third of the new building standard (below 34% NBS) are considered earthquake prone

FSP - **Foam Sandwich Panel** can also be known as EPS. The term FSP is a broad term which for any time of panel that includes foam and can include EPS, PIR, ACP. These below are 5 main groups of FSP

- EPS/PIR (Polyisocyanurate) where the use of EPS or PIR forms the external walls as well and can include internal walls and ceilings
- EPS/PIR where the use of EPS or PIR is to line internally a building or structure, or where there is the use of chillers or other standalone FSP units within a building or structure
- Aluminium Composite Panels (ACP) also known as Aluminium Composite Material (ACM) used as an architectural design feature on the exterior of buildings
- Polystyrene insulation and cladding systems forming part of the external envelope of a building and externally clad typically with a plaster render type finish and affixed to the framing structure of a building. FSP insulation can be underfloor or wall and ceiling spaces

 Spray on Polyurethane Foam forming a skin on the inside of a building or structure.

Any of these types of FSP need to be disclosed and percentages entered into the 'FSP Level' field. For example, a butchery where half the floor area is fridges equals 50% FPS

Helpful hint:

For property risks, guidance has been provided for the terms NBS and FSP in the construction tab. When the user hovers their curser over the field a description of each term if provided as shown.



Construction and **Protection** risk detail should reflect the brokers evidence from their submission. If evidence is not forthcoming to reflect the decision, please utilise 'Unknown'. The 'Water supply" will default based on the location entered. This may be overridden if more accurate detail is available from the submission.



Material Damage

By default, all perils reflect **Replacement value** coverage. Indemnity Value will default on the same but can be overridden as required. This detail is required for subsequent FENZ declarations, please ensure it is as accurate as possible against the risk detail on file.

The Puilding Total include all perils above. If Other Property' is utilized, please ensure the


The Building Total include all perils above. If 'Other Property' is utilised, please ensure the description is added.

Material Damage Natural Disaster

The peril-based data defaults into this section. The only additional information requirement is the **EQC Dwelling Count**. If you enter a value in this field, then the 'EQC Declared Values' section will appear.



This value then calculates the EQC Sum Insured within the 'EQC Declared Values'. Again, this section can be updated to reflect the risk and broker declaration.



Business Interruption

For this section, the 'All MD Locations' should be checked if the BI declaration is for all subsequent risks (see Add risk section in this document). The Indemnity Period input will default down to each period as a Sum Insured is entered



Business Interruption Natural Disaster

This section will reflect Business Interruption from above, this can be edited as required.

Tenants

For Property Owners, the tenant detail is imperative to accurately rate and underwrite.

Click 'Add'. A dialog box will open to capture the detail. Please complete in full.

Add all tenants starting with the highest risk to the lowest (i.e. you would load a Laundromat and/ or a café over before a retail shop)

Interested Party

Click 'Add' to open the dialog box and enter relevant details. Having this detail as accurate as possible will add value at Claims time. Populating this information will mean that your certificate correctly shows interested party details.

When all the risk detail is presented accurately to reflect the submission, click 'Save' to progress.

Answer **Underwriting Questions** by selecting Yes/No as applicable

The system will prompt you with a red validation message at the bottom of the page should you be missing any mandatory information:

Once corrected, click 'Next'

This will also save the risk for the first time.

You run the risk of the data being erased.

If all parameters are met, then you will be prompted to the 'summary' page and have the following options available:





Adding Documents

Utilise this function to exchange documents with your underwriter.

The 'Add document' button opens a dialog box.

Here you can select the 'Type' of document from the dropdown with options visible most file types are supported. Click 'Choose file' to open the File Explorer and select the document. Ensure the 'file name' size is less than the maximum of 110 characters.

All documents are saved against the customer record and into the underwriting system. Please clearly label/ name each document based on what you are submitting i.e. valuation, survey report etc.

Clicking 'Save' this document will be uploaded to the policy. This may not appear immediately. After a few minutes, when clicking on 'View Document' you will be able to see the list of successfully uploaded documents.

If no further action from the underwriter required for this risk, you can select 'Add risk' to add the next risk or 'Back to client' to review the client profile.

Adding additional risks:

Some risks can only be selected once, others multiple times. All available options will be presented here (please note that you will need to add General Liability risk first before you can enter Statutory or Employers Liability)

Motor Vehicles

The Occupation will carry through from the prior risk but this can be changed if necessary. You can add up to 11 Motor Vehicle risks per policy.

Select from the drop-down options for 'Vehicle Cover and Usage'

If the vehicle registration is not known at the time of quote request, tick the select 'Registration Unknown' box

'Heavy Vehicle' indicates a higher FSL Levy. The flag can only be changed by the underwriter – please utilise the 'Submit Referral' function if you believe this is not a heavy vehicle for the underwriter to update accordingly. Heavy vehicles are not in QBE's appetite.


Excess

To add Windscreen excess, please select. Should you wish to change the Minimum Amount' value, the excess type with automatically switch to 'Voluntary'. 'Imposed' excess cannot be edited and is what QBE underwriters have actioned.



Loss of Use

If you require Loss of use coverage, you need to select the tick box. If you hover over the 'Maximum Daily Limit' and 'Excess', an explanatory message will appear.

General Liability

The Occupation will carry through from the prior risk – for Liability it is imperative the Business Description matches the true exposure. For that reason, the occupation is editable by risk. This is particularly relevant for property owners, whereby the liability exposure may be over and above that of a property owner (i.e. a manufacturing risk)



Input the risk detail and Limit as required. You also need to add the building count (number of buildings)

Ensure the Building count is present for accurate property owners liability rating. Our expectation is the minimum Limit of Indemnity is \$1m

Add/ Remove Territory

Any territory outside New Zealand will trigger a referral. You can add up to 4 additional territories.

Answer **Underwriting Questions** by selecting Yes/ No as applicable

Click 'Next'

Statutory Liability

Statutory Liability can only be added once General Liability is added

Data input should reflect other liability risks. Where Retroactive Date is Unlimited or backdated, please ensure evidence is to hand of continuous prior cover.



The Retroactive Date will default to the Inception Date of the policy.

When you add either a Statutory Liability and/ or Employer Liability, the Expected Turnover from a General Liability risk, will pull through. You can still change/ update the expected turnover values for Statutory or Employer liability.



When an occupation of a property owner is selected, the user will have to complete a building count. Building count will only be visible to a user against a Statutory Liability risk for property owner occupations



Employers Liability

Employers Liability can only be added once General Liability is added

Follows same format as 'Statutory Liability' above.

When you add either a Statutory Liability and/ or Employer Liability, the Expected Turnover from a General Liability risk, will pull through.

You can still change / update the expected turnover values for Statutory or Employer liability.



Submitting a referral process

Should a quote require further consideration from a QBE Underwriter, you will be prompted to 'Submit Referral' via the 'Referral Required' status. Once you click

'Submit referral' this will trigger the referral process and lock the quote file to editing.



At this time, no other changes can be made (only by QBE).

The dialog will open, please add any covering comments to aid a prompt decision and response from the QBE Underwriter.

Referral expectations – It is expected that full underwriting information be presented to QBE along with a recommendation of what outcome you are looking for. The better, more concise submission, the easier it will be for QBE Underwriters to return a decision

Once submitted, the policy detail screen will reflect 'Referred to Underwriter' status

'Back to client' will navigate back to the client screen and you can monitor the state of your referral here under 'Status'

If the Status shows as 'Incomplete' the risk detail still requires updating and resubmitting to OBE.

Referral responses may include a Decline. Where this status is shown, the user will not be able to bind this version of the risk.

Next Step:

Once a referral has been completed by your QBE Underwriter, a notification email will be sent. The updated status will be reflected on the risk through multiple views including the Find quote/policy.

The Policy details screen will now show the premium and detail any additional clauses added of the risk, including the any commentary from the Underwriter.

Underwriter Notes: Hi Team, Please supply details of the fire protection system via Add Documents. QBE UW

Documents will now become available assigned to the status. We recommend reviewing this document prior to sending and to review the full package terms.

You can either download the document or email a copy to yourself

You can either continue your negotiation by editing risks as new details come to hand or elect to Bind.

Bind cover

Clicking Bind cover will move the risk to a Bound status. Please ensure all risk details accurately reflect your placement on behalf of the Insured and Broker.

Close Cover

Prior to clicking close, we recommend using 'Add Document' to save the Invoice/Coverage Summary.


The 'Alternative Reference' needs to be updated with your Final **Invoice Number**. This is imperative for accurate payment matching against the premium bordereaux. There is a limit of 80 characters in this field.

If you have multiple closing numbers, please use the word 'Multiple' as your reference

Click 'Proceed'



The policy is now **Live**, and this will be reflected on the Client Details screen.

You will navigate back to the summary screen where you can access the policy schedule and certificates as required.

Once processed, the Policy Schedule and Certificate will now be available to 'download' or 'email to yourself'

To check the library at any time, you can use the 'View Documents' function

Closing an expired quote

Users now can now Close an expired quote that has already been bound if the following criteria has been met

- Broker Xchange policy status is shown as "Bound Awaiting Closing"
- The quote expired 120 days or less from the policy inception date.

If a user attempts to Close a quote that has the policy status of "Bound- Awaiting Closing" but the quote expired by more than 120 days before the inception date, they will not be able to Close.



Finding a quote

Quotes and policies > Find quote / policy: search by the unique identifier (quote/ policy number)

Clicking on the 'Client Name' will take you to the client's home page where you can see all quotes against that client

Viewing terms

The 'View terms' button has can be found in the Policy Summary page. When selected, a pop up is shown which presents the terms for the quoted risk. Terms are only displayed if the following criteria is met.

Cancelling/ Deleting a risk

When adding a risk, but don't want to save that risk to the quote, you can **cancel** out of the risk. Note: When you add a risk and cancel, the risk will not be saved to the quote. When you edit a risk and cancel, the changes you made will not be saved.

You can only delete a risk that you can edit. Click the 'Delete Risk' button. A pop-up will be presented to you to validate your request.

- a. If you click Ok, the risk will be deleted.
- b. If you Cancel, you will be routed back to the Summary screen. The risk will still be ticked within the delete column. Please untick the risk if you no longer wish to proceed with the deletion.

When can a risk not be deleted?

- You cannot delete the last remaining property risk.
- You cannot delete a General Liability risk when the quote also has a Statutory Liability or Employer Liability risk.

If you are not allowed to delete a risk, a warning message will display.

Loading an endorsement/ Update cover

The policy must be live in order to use the Update cover feature

Search for the policy you wish to update by either searching via 'Find/add client' or via the 'Find quote/ policy'

Once you are in the policy details page, select 'Update cover' button. Record the 'Reason Description' and the 'Effective Date'. Click Next

At this stage, you can either 'Edit', 'Add Risk', 'Delete Risk', 'Bind' or 'Submit Referral'. Same process to be followed as noted previously under 'Loading a Quote'

Renewing Cover

When a policy is up for renewal, you will be notified via email of this.

On the client page you will see the relevant policy with the status 'Under Renewal'



Actions available:

- Review the terms (View terms)
- QBE needs to be informed if there are any material changes to the risk, including any unreported claims or circumstances that might result in a claim prior to binding
- Utilise the BIND function prior to the inception date of the renewal invitation.
- Utilise the CLOSE function within 30 days. Please ensure you upload the invoice and input the Alt Ref

Even though the risk may be suitable, there are other controls and restrictions to ensure we align to QBE's risk appetite.

1. Endorsements/Clauses/Exclusions

Endorsements can apply:

- automatically, driven by rules (e.g. by ANZSIC, Hazard Class)
- on system referral as part of an underwriting review
- on system referral, as requested by the broker
- QBE requested (e.g. post Risk Survey)

Endorsements may also be referred to as Warranties, Exclusions or Clauses.

Unless otherwise covered by this document; any non-standard endorsement must be approved by QBE in the first instance.

2. Period of insurance and Backdating coverage

All insurance periods are limited to 12-months.

There are several system-based rules that may cause referral;

information and any disclosure or copying of this document is unauthorised and strictly prohibited.

Scenario 1 – Where the broker tries to backdate the policy inception date more than 2 days however, you can allow where you can prove and document there has been:

- A former prior instruction from the customer aligned to a correct period
- There is no material change the risk, including no claims or no known circumstance that may give rise to a claim (currently unnotified).

Or

Scenario 2 – Where the broker tries to bind more than 60 days in the future. Where a period falls outside of your authority, refer internally.

Backdating coverage is defined as agreeing to issue a new policy, reinstate a cancelled or non-renewed policy, or add coverage to an existing policy, where the effective date occurs earlier

than the date the underwriter originally agreed to issue or reinstate or change the affected policy. The QBE platform allows brokers to backdate a policy two days.

QBE's philosophy is not to back date cover. However, if there are good reasons to do so, (e.g. client relationship / strategic considerations/ system issues). Where required, the following process may be required:

- Evidence of client instruction
- An acceptable "No Claims Declaration" or "no known circumstances" letter must be secured from the client. (Broker completed documents are not acceptable)
- Finally, the risk should be referred to QBE for sign-off supported by a covering email summarising the rationale behind the backdate request.

4. Underwriting declarations questions

We ask disclosure questions as the answers to these questions could affect the level of premium or excess, any exclusions or the decision to provide insurance at all. 




